<u>Training pathway to become an accredited BUSS® practitioner for work with children, young people and families</u>

Most practitioners will have attended an Introduction to BUSS® webinar before they commit to this formal training. This is highly recommended.

This document outlines the training to become an accredited BUSS® practitioner, and how to maintain that accreditation. There is a separate document pertaining to Groupwork / LEAPlets training. Eligibility for training is covered on the BUSS® website here - https://bussmodel.org/training/#level-two

Training progresses through 3 levels, with participants only progressing to the next stage on successful completion of the previous stage. There is no minimum recommended time between stages, and practitioners can progress through the stages at their own pace in a 3-year time frame (although there may be some preparatory work required if there is a long gap between Level One and Two training).

The requirement is that participants attend all full days of training. While it is understood that there are occasions when things happen that it's not been possible to anticipate, we are unable to support people to make up more than 1.5 hours of missed teaching.

The requirement is that participants attend all days of training, not missing more than 1.5 hours of the duration of the training.	 Training records. Level Three	 Attendance at the Level Three introduction session. Work with 4 children, young people and families, aged between 5 and 18, successfully completing a BUSS® intervention with each one. Preparation of recordings of sessions, reports and reflective logs. Attendance at individual and peer group supervision. 	 Training records. Submission of recordings, reflective logs and reports. There is a review of progress after successful completion of the 2nd case. For practitioners who have reached the requirements starred* after 2 cases, supervision may reduce for case 3 and 4.



Core Competencies of BUSS® Practitioners

These will form the basis for work throughout the training. Practitioners progressing from Level Two through Level Three training will review this document regularly throughout the supervision process.

Demonstrating an understanding / ability to assess parental capacity in relation to BUSS® and to support parents/ carers in their decision.

* Setting goals for BUSS® work that are specific to the development of the child's foundation sensorimotor systems, explaining how these goals will impact on the child's everyday life.					
Supporting families to set and review goal based outcomes that are relevant to BUSS® and achievable based on parent/carer and child views and outcome of the BUSS® assessment.

Being proficient at writing BUSS® reports and summaries at each stage of the progress, typically after every contact with the family. These reports will be written using the BUSS® template and will encompass the values of empowering parents/carers and using the parent/carer - child relationship as the main agent of change. It is expected that practitioners will need increasingly less support with this as the practicum progresses.					
At the end of the intervention, being able to review progress and be part of the process of considering if there is a helpful next step.					



Accreditation

On successful completion of 4 cases with children of differing ages between 5 and 18, showing evidence of all core competencies, there will be a final meeting with Katie Wrench, Head of Clinical Services and / or Sarah Lloyd, Director of BUSS®, to formally complete the training process. A certificate will be issued at this stage.

Accreditation is valid for 4 years. *In order to maintain accreditation, it is necessary for practitioners to*:

- Complete the declaration form (see Appendix I)
- Pay a fee for the administration of the accreditation and a fee for membership of the community of Accredited BUSS® Practitioners.
- If practitioners would like to have their profile and details on the list of Accredited BUSS® Practitioners on the BUSS® Model Ltd website, they must supply the necessary information.
- BUSS® Practitioners must continue to receive supervision from a BUSS® Consultant for their BUSS® work. Working with up to 10 families concurrently, the minimum requirement for accredited practitioners is to attend 9 sessions of supervision per year.
- To maintain accreditation, a practitioner must complete a minimum of 46 hours of supervised BUSS® practise within one calendar year – this equates to completing the intervention with 2 families. In circumstances where practitioners are unable, for whatever reason, to practise for a period of time, we would work to support them to meet the requirements of accreditation e.g. providing individual supervision for the first case.
 - Supervision at this level will continue to comprise a combination of preparatory work by the supervisor (reviewing videos and reports) and face to face supervision.
- Maintain professional indemnity insurance.
- All BUSS® practitioners must adhere to the highest professional standards. All practitioners must maintain membership of their professional body (e.g. HCPC) and uphold the values and standards of that body. Any behaviour, be it personal or professional, on the part of any accredited practitioner that brings BUSS® into disrepute will result in immediate removal from the register of Accredited BUSS® Practitioners. Information about any concerns will be passed on to the individual's professional / accrediting body. A practitioner must inform BUSS® if there is any change to their professional registration.

Note - There are occasionally exceptional circumstances in which we agree to train people who do not have a core clinical or Social Work training. In such cases, accreditation is limited to their continuing to work within an organisation with clinical and / or social work staff, who agree to take clinical responsibility for their ongoing BUSS® work.

In order to support the ongoing development of practitioners, BUSS® Model Ltd will:

• Ensure supervision with a Consultant BUSS® Practitioner is available for either group or individual supervision.



- Keep practitioners up to date with any additions to the library of BUSS® activities and any developments / changes to the way the intervention is framed or paperwork pertaining to the model.
- Offer discussion and learning opportunities to keep abreast of the emerging evidence base for BUSS®, research and development. BUSS® Model Ltd will host these sessions for the community of BUSS® practitioners, sharing articles, podcasts and research in related fields that may be of interest.
- Send details of training and CPD that may be of interest. One day we hope we'll be able to organise a conference!

What happens when membership renewal requirements are not met?

- The practitioner will be charged a late fee if the membership fee is not paid on time.
- The practitioner will lose their status as an Accredited Practitioner in BUSS®.
- The practitioner's name will be removed from the website.

How might the status of accredited practitioner be restored?

- All accredited practitioner requirements must be met.
- Fees must be paid in full.
- Levels of clinical supervision need to be agreed with the BUSS® supervisor.

Next Steps - BUSS® Consultant Status

We're keen to support accredited practitioners to work towards becoming a BUSS® Consultant, able to supervise BUSS® practitioners and be involved in training. This process is a combination of supervised practice, reflection and evaluation of practice as well as involvement in evaluation and ongoing professional development in BUSS®. We'd typically expect a practitioner working with a caseload of 8 - 10 families concurrently, to be eligible for consideration for Consultant status after about 18 - 24 months, which would equate to having worked with approximately 30 families.

Appendix I – Declaration Form

Declaration concerning BUSS® Practitioner Accreditation/Renewal of Accreditation

An Accredited BUSS® Practitioner must fulfil the Accreditation / Renewal of Accreditation requirements for as long as you practise as a BUSS® Practitioner. BUSS® Model Ltd requires you sign the declaration below and return it to accreditation@bussmodel.org

- I understand that BUSS® Model Ltd requires me to fulfil the requirements of Accreditation/Renewal of Accreditation for my BUSS® Accredited Practitioner status. These requirements are:
- o A minimum of 46 hours of supervised practise within one calendar year
- o Attendance at 9 supervisions per year
- o Payment of the BUSS® accreditation administration fee
- o Payment of the BUSS® accreditation community membership fee, payable every four years
- o Maintaining professional indemnity insurance and
- o Maintaining accreditation and registration with a professional body (where applicable e.g. HCPC).
